The Municipal City Council of Port Louis is inviting bids through Open National Bidding for the Procurement of Services for Street Cleaning, Refuse Collection and Disposal including carting away Post Cyclonic Waste (for Lot 3 & Lot 5) for a period of 36 months in the area of the Municipal City Council of Port Louis from contractors who are registered with the Ministry of Local Government and having proven experience in the field of Solid Waste Management. The Contract period is two years renewable on a yearly basis.

Interested bidders are requested to download the bidding document on the government procurement portal: publicprocurement.govmu.org or can purchase a complete set of Bidding documents in English from the **Municipal City Council of Port Louis, The Chief Executive Office, 2nd Floor, Jules Koenig Street Port Louis, Tel: 4056600** upon payment of a non-refundable fee of Mauritian Rupees five hundred only (**Rs 500**) in cash or by bank cheque drawn in favour of the Municipal City Council of Port Louis. Bidders should not submit their bids electronically.

Bids in sealed envelope clearly marked with the name of the project and CPB reference number (**CPB/13/2019**) must be addressed to **The Chief Executive, Central Procurement Board and deposited in the tender box at the Central Procurement Board's Office** Central Procurement Board, 1st Floor, Social Security House, Julius Nyerere Avenue, Rose Hill **on Tuesday 14th May 2019 up to 13.30 hours (local time) at latest.**

Bids shall be opened physically in the presence of Bidders/Bidders' representatives who choose to attend in the **Conference Room of the Central Procurement Board** on the same day as from **14.00 hours** (local time).

 - To split the contract lot wise
 - To annul the bidding process and rejects all bids at any time prior to the award of the contract as per provisions at section 39(1) of the Public Procurement Act 2006.allocate the contract by lot to one or more service providers based on the lowest evaluated substantially responsive bid per lot;
