Bids in sealed envelope clearly marked "**Design & Construction of Municipal Funeral Parlour at La Tour Koenig, Port Louis**" and bearing the name, address of the bidder and Procurement Reference number should be addressed to **The Chief Executive, and deposited in the Tender box at the Municipal City Council of Port Louis at the address given at paragraph 8 on Monday 20<sup>th</sup> January 2020 up to 11.00 hours (local time) at latest.**

5. Electronic bidding shall not be permitted. Bids received after the deadline for submission of bids will be rejected.
6. Bids will be opened physically in the presence of Bidders/Bidders' representatives who choose to attend in the **Chief Executive's Office** at the address given at paragraph 8 on the same day as from **11.30 hours** (local time).
7. The Municipal City Council of Port Louis reserves the right to reject any bid, to annul the bidding process and reject all bids at any time prior to award of contract as per provision of Section 39 (1) of the Public Procurement Act 2006.
