### **Open National Bidding**

The Municipal City Council of Port Louis invites bids through Open National Bidding method from eligible Contractors registered with CIDB in Building Construction Works of a minimum Grade E for the **Extension of Office Building on Parking Area and Audio Visual Section at The Municipal City Council of Port Louis.** Participation is limited to Citizens of Mauritius or entities incorporated in Mauritius. Joint Ventures should be among entities incorporated in Mauritius.

1. Interested eligible bidders may obtain further information from the **Chief Executive, The Municipal City Council of Port Louis, Jules Koenig Street, Port Louis** and inspect the Bidding Documents at the address given at paragraph 8.

A complete set of Bidding documents on CD in English may be purchased from The Municipal City Council of Port Louis at the address given at paragraph 8 upon payment of a non-refundable fee of Mauritian Rupees five thousand only (**Rs 5,000**) in cash or by bank cheque drawn in favour of The Municipal City Council of Port Louis. Bids in sealed envelope clearly marked "**Extension of Office Building on Parking Area and Audio Visual Section at The Municipal City Council of Port Louis**" and bearing the name, address of the bidder and CPB reference number should be addressed to **The Chief Executive, Central Procurement Board and deposited in the Tender box at the Central Procurement Board's Office at the address given at paragraph 8 on Wednesday 24<sup>th</sup> October 2018 up to 13.30 hours (local time) at latest.**

4. A pre bid site meeting will be held at the **The Municipal City Council of Port Louis**, City Hall, St Jules Koenig Street, Port Louis on **Monday 08<sup>th</sup> October 2018** at **13:30 hours**.
5. Electronic bidding shall not be permitted. Bids received after the deadline for submission of bids will be rejected.
6. Bids will be opened physically in the presence of Bidders/Bidders' representatives who choose to attend in the **Conference Room of the Central Procurement Board** at the address given at paragraph 8 on the same day as from **14.00 hours** (local time).
7. The Municipal City Council of Port Louis reserves the right to reject any bid, to annul the bidding process and reject all bids at any time prior to award of contract as per provision of Section 39 (1) of the Public Procurement Act 2006.
