### **Procurement of Services for Street Cleaning, Refuse Collection and Disposal including Carting away of Post Cyclonic Waste in Port Louis – (Lot 6) - Year 2017-18**

#### **Open National Advertised Bidding**

1. The Municipal City Council of Port Louis invites bids through Open National Advertised Bidding in sealed envelopes from bidders who are registered with the Ministry of Local Government as Scavenging Contractor and having at least 1 year experience in Street Cleaning, Refuse Collection and Disposal Services including Carting away of Post Cyclonic Waste (Lot 6). The Contract period is two years renewable on a yearly basis.
2. Bidding shall be conducted according to the provisions of the Public Procurement Act 2006.
3. Bidding Documents may be consulted during office hours at the Registry, Chief Executive's Department, 2<sup>nd</sup> Floor, Main Building, City Hall, Port Louis.
4. A complete set of bidding documents in English may be purchased from the Municipal City Council of Port Louis at the address below upon payment of a non-refundable fee of Mauritian Rupees two hundred only (Rs 200) in cash or by bank cheque drawn in favour of the Municipal City Council of Port Louis (***Time – 09 00 hours to noon and 12 30 hours to 15 00 hours***) or downloaded free of charge on the government portal at the following address: [publicprocurement.govmu.org](http://publicprocurement.govmu.org)

5. Bids must be lodged in the Tender Box at the address below on **Monday 14<sup>th</sup> August 2017 up to 11 00 hrs (local time) at latest.**
6. Electronic bidding shall not be permitted. Late bids will not be accepted.
7. Bids will be opened in the Committee Room, The Municipal City Council of Port Louis, 2<sup>nd</sup> Floor, Main Building, City Hall, Port Louis on **Monday 14<sup>th</sup> August 2017 at 11 30 hrs (local time)** in the presence of Bidders/Bidders' representatives who choose to attend.
8. The Municipal City Council of Port Louis reserves the right to reject all bids, or cancel the public procurement proceedings at any time prior to the acceptance of a bid as per provision of Section 39(1) of the Public Procurement Act 2006
