### Open National Bidding

1. The Municipal City Council of Port Louis invites bids through Open National Bidding in sealed envelopes from Contractors registered with CIDB under appropriate grade in Building Construction Works for the **Renovation of Port Louis Theatre – Phase I**. Participation is limited to Citizens of Mauritius, or entities incorporated in Mauritius or Joint Ventures among entities incorporated in Mauritius.
2. Interested eligible bidders may obtain further information from the **Chief Executive, The Municipal City Council of Port Louis, Jules Koenig Street, Port Louis** and inspect the Bidding Documents at the address given at paragraph 10.
3. A complete set of Bidding documents on CD in English may be purchased from The Municipal City Council of Port Louis at the address given at paragraph 10 upon payment of a non-refundable fee of Mauritian Rupees ten thousand only (**Rs 10,000**) in cash or by bank cheque drawn in favour of The Municipal City Council of Port Louis. 4. Bids in sealed envelope clearly marked "**Renovation of Port Louis Theatre – Phase I**" and bearing the name, address of the bidder and CPB reference number should be addressed to **The Chief Executive, Central Procurement Board and deposited in the Tender box at the Central Procurement Board's Office at the address given at paragraph 8 on or before Tuesday 15<sup>th</sup> August 2017 up to 13.30 hours (local time) at latest.**

5. A pre bid site meeting will be held at the Port Louis Theatre at Corner St Jules Koenig and Remy Ollier Streets, Port Louis on **Wednesday 26<sup>th</sup> July 2017 at 13:30 hours**.
6. Electronic bidding shall not be permitted. Bids received after the deadline for submission of bids will be rejected.
7. Bids will be opened physically in the presence of Bidders/Bidders' representatives who choose to attend in the **Conference Room of the Central Procurement Board** at the address given at paragraph 8 on the same day as from **14.00 hours** (local time).
8. The Municipal City Council of Port Louis reserves the right to reject any bid, to annul the bidding process and reject all bids at any time prior to award of contract as per provision of Section 39 (1) of the Public Procurement Act 2006.
9. Bids shall be accompanied by a Bid Security for an amount of One (1) Million Rupees as per format specified in the Bidding Document. Bid without a Bid Security shall be rejected.
